I took the radio and kill pack at the same time I stayed on the platform till called down by the sheriff's department and Disney security. I then stayed at the bottom until told to clock out by my manager.

Approx 2min after impact both trains were moved back into monorail Station.

My boyfriend Sean and I were in the tram line waiting to get on, and we heard a loud sound consisting of crashing and metal scraping noises. People that were behind us started saying "What happened?" "What was that?" Then almost all of the people waiting in the lines started running toward the bottom of the platform where we could see the Pink and Purple monorails had collided with each other. At first there wasn't any cast members in the area but within seconds to minutes they were c/m (cast members) asking everyone to move back, my boyfriend Sean flashed his EMT-P Budge to help. As he was doing this the trams started moving toward the platform still connected. Sean ran up to the platform to assist. I was then asked to move back between the back of the ticket booth and the planters. After a few minutes we were then asked to move to the front of the ticket booths, where I waited for Sean to return. After

I am visiting from Palm Beach County FL. On July 5<sup>th</sup> ~~at~~ I was sitting on the bench outside the bathroom waiting to be picked up (my grandmother is handicapped so we were waiting on our car). The bathroom is near the ticketing booth inside Magic Kingdom. We noticed that the approaching monorail was about to hit a stationery car that was right above where we were sitting. I got up and saw the train crash with a very loud sound. The car in front didnt seem to have much damage but, the car that rammed into the first car seemed to crush like an accordion. Parts including glass, a door, metal and just pieces of the train, seemed to crumble to the ground.

It was horrific. I immediately called my husband who was in the handicapped parking lot, and had him call 911. I ~~then~~ then watched as the train backed up to the platform (the cars now attached). The damaged car seemed to catch on the rail and tear more. We saw more pieces fall and could hear crunching sounds. From this time on we were asked to step away and watch from afar.

I failed to mention earlier that the stationery vehicle (the one that was hit) was parked between the ticket booths and the platform (past the platform) so therefore the car that hit overshot the platform.

I am leaving Disney on 7/5/09

I would say that it was about 3 or 4 minutes until the train was backed up to the platform.

What I saw was Monorail Pink backing into the station for a line switching. Monorail Purple was suppose to come into the station and wait until this switch was completed. <sup>at which</sup> ~~when~~ I saw Monorail Pink coming on the left, and Purple coming from the right, <sup>at</sup> ~~then~~ I realized both trains were coming into the same station, not two different beams and platform stations. This all happened on the morning on Sunday, July 5th, 2009, <sup>at approximately</sup> ~~in the~~ around 02:00 am. The Purple train was almost at a stand-still, while the Pink train was moving at approximately three (3) to five (5) mph. in reverse.
