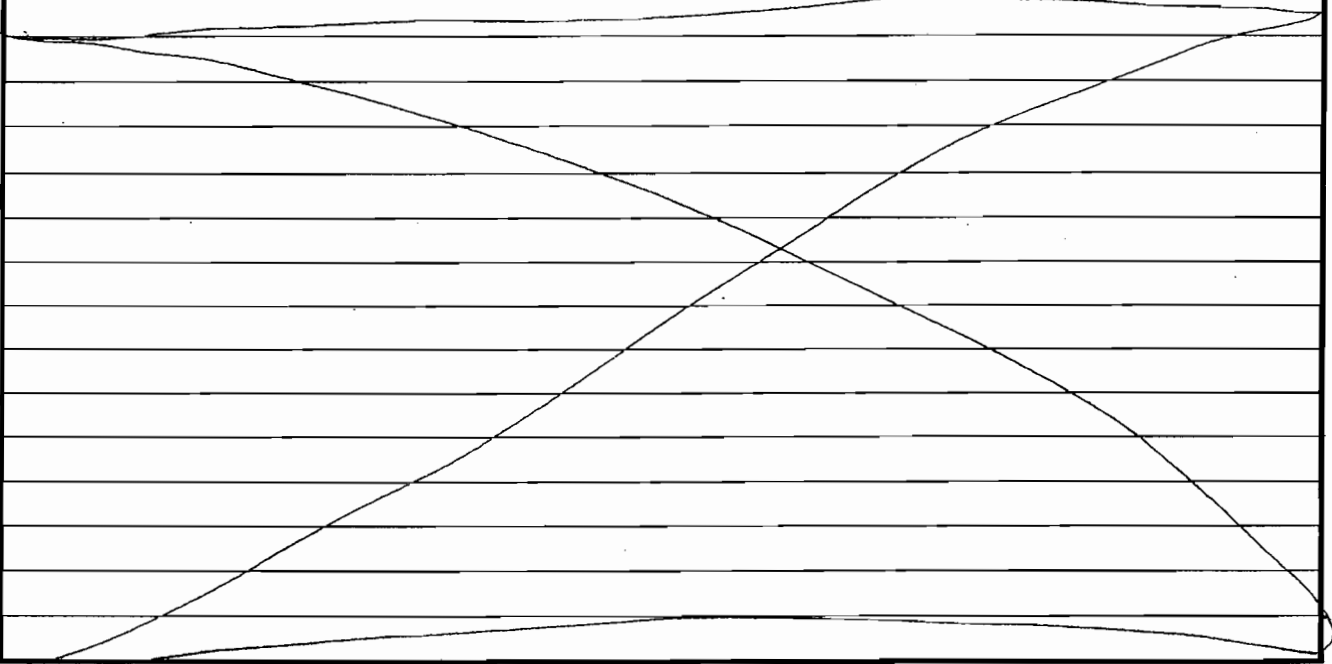

 I run up to tower to call 911.

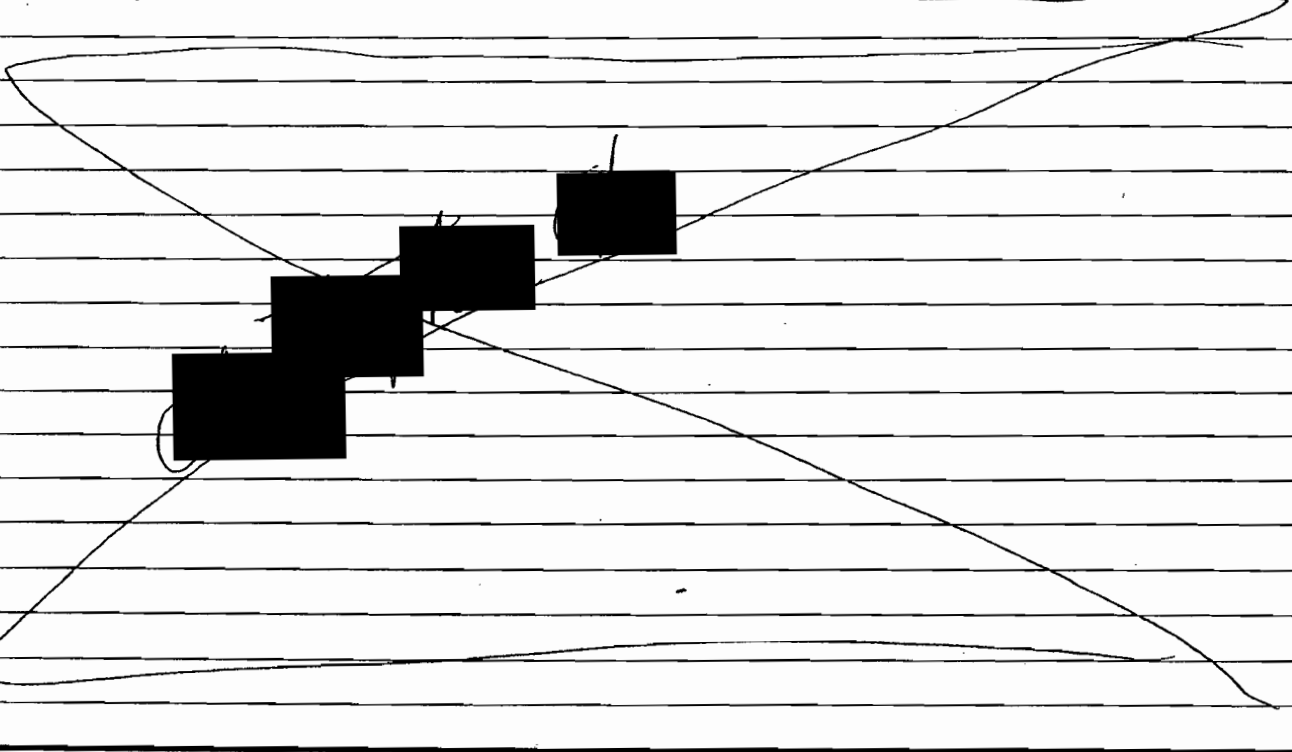
